

Between Words and Images. Disseminating Knowledge in Illustrated Student Notebooks

From the late fifteenth century to the end of the eighteenth century, note-taking during lessons at university gave rise to the practice of illustrating handwritten volumes, or *dictata*. Our contribution suggests a typology of images frequently added in lecture notebooks, and sheds new light on the various roles fulfilled by such visual materials. We argue that not only “scientific” images (directly resonating with the text) performed a clear didactic function, but that this was the case for other kinds of images as well, such as emblems, allegories, humorous or satirical sketches, and title pages. We also emphasize the importance of copying and drawing after prints, and the materiality of prints experienced by students, in particular through the recuperation of existing emblematic compositions. Through such a handiwork activity, students would play with various meanings, customize their own manuscripts, and absorb knowledge in a sustainable way.
